- 3. Financial Status (10 min.)
 - a) 2022 Budget Update: Tim (document attached to meeting invite email)

Summary (2022 actuals vs. planned):

- ~\$11K ahead on Income
- ~\$5K ahead on spend plan
- Total ~\$16K in black

Judy noted that plate offering amounts and pledge offering amounts may be blended differently, yet won't affect bottom line.

Balance as of end of February: ~\$60K (operating acct); ~\$3600 (building acct)

- b) Investment Presentation: Richard (document attached to meeting invite email)
 - Richard tasked with options to place excess funds.
 - Trustees of the Funds (ToTF) Account. Endowment Fund across 150
 Episcopal Churches Mission Aligned Investing. Average 4.5%,
 conservative investments. Ability to pull \$ anytime, yet not used as

deposit/withdraw each month. Recommendation is to add excess funds and let it sit for future.

- Cindy made point that managing our funding via investments will demonstrate with Diocese that Good Shepherd is responsible for fiscal health.
- Richard made point for this to be considered as a way to pay ourselves first. Just get started.
- Tim gave example from Warden's meeting earlier this week. Churches shared their troubles of getting money from fund. Believe this is a growing pains issue, not a long-term issue.
- Richard made motion to reallocate \$22K. Cindy 2nd the motion. Unanimous vote

VESTRY DECISION: Move \$22K to fund. Richard and Cindy will do paperwork.

 Purpose: Is for our purposes. Will revisit how we use returns on investment during annual meeting.

- 4. Facility Maintenance and Improvements (10 min.)
 - a) Prayer / Meditation Garden: Cindy
 - Price increase due to labor involved in planting. \$2K for topsoil (added \$1K from estimate), necessary due to rocky terrain. Does include big tree.
 - Cindy recommended prioritization of what needed to be planted this year to help contain soil.
 - VESTRY DECISION: Eliminate labor for planting and elicit volunteers from Good Shepherd members.
 - Tim recommended putting together a committee.
 - b) Scott Grant Request: Tim

Purpose: Prayer/Meditation Garden

ACTION: Due 3/18. Signatures by Cindy and Lois.

How much do we move forward before we hear confirmation of Scott Grant? Cindy identified \$4,100 as priority to move forward before grant. Tim agreed with moving forward with existing church funds.

c) Parking Lot / Driveway: Tim

Price to re-pave parking lot plus handicap parking would be \$14,500.

Tim recommended not moving forward yet.

ACTION: Tim will get additional cost estimates.

d) Church Sign / Mailbox: Tim

Work in progress. Task for Richard as special projects.
